

Chancellor's Measure No. 2/2025 List of Fees

Article I. General Provisions

- Pursuant to Article 10 of the NEWTON University Statute and the current NEWTON University Directive of Fees the Chancellor of NEWTON University hereby establishes by means of a Chancellor's Measure this List of Fees.
- 2. The List of Fees determines the current amount of fees charged by NEWTON University in connection with accredited university study programs and participation in lifelong learning and continuing education programs and courses.
- The specific amount of tuition fees is determined by the respective contract between NEWTON University and student or participant in lifelong or continuing education at NEWTON University.
- 4. Specific exemptions, discounts or concessions may be set permanently or for a specific period of time in the assessment of individual fees. The application of such exemptions, discounts or reductions may be subject to the fulfilment of certain conditions by the NEWTON University student or participant in lifelong or continuing education at NEWTON University.
- 5. At the request of a student, or a participant in lifelong or continuing education, the relevant fee may be waived on an individual basis in justified cases (typically for health reasons or reasons related to pregnancy, childbirth or parenthood, or for other reasons of special consideration). The waived fee is then not prescribed at all in the particular case or is considered to have been duly paid.

Article II. Types of fees and amounts of payment

- 1. The different types of fees, including their specific amounts, are set out in the Annex to this Measure.
- For NEWTON University students enrolled in Bratislava in the Slovak Republic and for participants in lifelong or continuing education at NEWTON University taking place in Bratislava in the Slovak Republic, the specific fee amounts calculated in euro currency (EUR) are applicable (see Annex to this Measure).
- 3. For students enrolled in distance learning programmes conducted in English, the specific fee levels are valid in the currency in which the price of their studies (i.e. tuition fees) is set according to the study contract they have signed with NEWTON University.



Article III. Permanent discounts and benefits

- 1. Some of the fees are not charged to students in the Premium Care program (see the attachment specifying the amount of individual fees below).
- 2. If the relevant contract between NEWTON University and a NEWTON University student or a participant in lifelong or continuing education at NEWTON University contains a price or other more favourable provision for certain fees governed by the List of Fees, the contract shall prevail in determining the amount of such fees.

Article IV. Final Provisions

- 1. This Measure shall enter into force and take effect on 1 September 2025.
- 2. On the date of entry into force of this Measure, the all previous Chancellor's Measures regulating the level of fees at NEWTON University are revoked.
